Thirty Area Executives Named to 41st Kansas City Tomorrow Leadership Class

The Civic Council of Greater Kansas City has announced its 41st Kansas City Tomorrow (KCT) leadership class. Potential participants were nominated earlier this year and were selected through a competitive process that included in-person interviews.

“This year’s KCT class is a very strong and diverse group of Kansas City professionals,” said Paul Holewinski, President & CEO of Dickinson Financial Corporation and chair of the KCT Leadership Group, the Civic Council committee that selected the 2019-2020 participants. “We are excited about the upcoming programming and KCT year, and our Civic Council members are looking forward to interacting with the KCT class.”

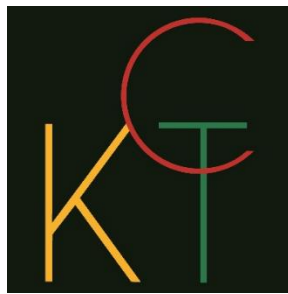
The thirty business, nonprofit and public sector executives began the ten-month program on August 23, 2019 and complete the experience in June 2020. KCT’s curriculum focuses on the region’s most pressing issues, such as education, economic development, diversity and inclusion, and the KC Rising initiative. The goal of the KCT program is to prepare its participants for civic leadership roles in the Kansas City region. “The Civic Council created the KCT program to help educate rising executives about the key challenges and opportunities facing our region,” said Civic Council chair Bill Gautreaux. “Ultimately, we hope that many of these KCT participants will go on to take a leadership role on an important community issue,” he added. “That could mean serving in appointed or elected office, joining a nonprofit board or community task force, or stepping up in some other way in our region.”

Once they complete the program, participants are eligible to join the KCT Alumni Association (www.kctaa.org), an independent, non-profit organization that allows the more than 900 graduates of the program to stay connected and explore opportunities for civic leadership.
